Stakeholder Engagement for Non-Allocated CRRSA and ARP Funds

- DECAL contracted with Urban Institute to conduct stakeholder engagement activities with providers, teachers, families, other Georgia partners, and DECAL staff.
- Activities included surveys, focus groups, and administrative data analyses.
- Output:
 - 9 recommendations with possible action items
 - Report of findings, executive summary,
 DECAL executive leadership briefings

Stakeholder Engagement Recommendations

- 1. Provide Support to Encourage More People to Become and Remain Child Care Teachers
- 2. Focus Attention on and Provide Information about Basic Health and Safety
- 3. Reconsider Group Sizes and Child-Staff Ratios
- 4. Provide More Accessible Information to Families About Available Early Care and Education Services
- Consider How to Support More Providers in Offering Care, Providing Longer Hours, and Participating in CAPS



Stakeholder Engagement Recommendations

- 6. Support Providers in Taking Care of the Social Emotional and Behavioral Needs of Children
- 7. Consider New Benchmarks for Affordability of Care in Georgia, including Limits for CAPS Participation and Parent Contributions When Receiving CAPS
- 8. Consider How to Sufficiently Support CAPS to Increase Responsiveness to Parents
- 9. Offer Child Care Providers Additional Grants and Supports for Financial Sustainability and Business Planning

 - May also include submissions of the research to conferences, peerreviewed journals, etc.







- Reflect a change in the Employees' Retirement System employer contribution rate to fully fund the actuarial determined employer contribution, provide for a cost-of-living adjustment for retirees, increase the employer 401(k) match for GSEPS employees, and fund the employer share of accrued forfeited leave for retiring employees = \$3,455
- Reflect a change in the Teachers' Retirement System actuarially determined contribution from 19.81% to 19.98% = 135,928
- Reduce funds for training and experience for Pre-K teachers = \$(2,103,643)




Inclusion Training: New 2022!

- Three-part training focused on the foundations of inclusion.
- Open to licensed child care centers, and family child learning homes.
- Upon completion of all three sessions, each individual participant will receive a \$125 stipend and 1 BFTS credit hour.
- Each center and FCCLH will a materials kit to help to promote program-wide inclusive classroom practices program-wide.





Early Learning Multi-Tiered System of Support



Pyramid State Leadership Team

- The Pyramid Model State Leadership Team (PMSLT) is a cross-sector group of early childhood stakeholders that collaborate to resolve state-level barriers and embed Pyramid Model practices into statewide systems.
- Georgia's PMSLT includes 21 individuals representing eight state agencies, universities, and nonprofit partners:

Supporting Family Child Care



- 6-month grant opportunity for FCCLH providers serving children birth to five.
- Designed to assist providers in developing strategies to support strong social emotional development and positive behavior through responsive relationships and high quality, predictable environments.
- Grant components:
 - Weekly Coaching Sessions
 - SEEDS Institutes (4)
 - Grant materials:
 - Technology package
 - Learning materials package to support social emotional development
- July-December 2021: Cohort 1, 31 FCCLH

Supporting Family Child Care

- 96% of surveyed FCCLH participants:
 - Agreed/strongly agreed coaching sessions and grant activities improved their use of social emotional strategies in their FCCLH.
 - **Agreed/strongly agreed** they will use the strategies they learned beyond the grant period.
 - Agreed/strongly agreed the children enrolled in their FCCLH benefitted from their participation in the grant.



Pre-K Enrollment







Changes made annually

- Beginning of the state fiscal year (July 1)
- Beginning of the federal fiscal year (October 1)

Reasons for rule changes

- Health and safety
- Quality improvement
- Child Care Development Fund requirements

Licensing rule change process



Rule change timeline

- February Annual rule review
- May specific rule changes identified and presented to Board
- July public webinars
- August public hearing & Board vote
- October 1, 2022 effective date



Proposed 2022 licensing rule changes

- Update language referencing the Division of Family and Child Services
- Require parental notification of communicable disease to include virus or illness identified during a public health emergency
- Specify types of evidence and documents programs must save and make available to the department


The Coaching Cycle: Action-Planning Observation Reflection/Feedback

Federal Programs Updates

Elisabetta Kasfir, Deputy Commissioner for Federal Programs



CAPS has **expanded** to serve **10,000** additional children.

To help make more families eligible, CAPS income limits within **Very Low Income priority group** and **income at initial eligibility** have increased.

Changes went into effect November 1, 2021.

Increased Income Entry Threshold from 50% to 85% SMI

For a family of 4, the income eligibility increased to

\$72,124 (85% SMI)

\$42,426 (50% SMI)

Effective November 1, 2021, to meet income eligibility requirements, the household income (for a family of 4) must not exceed **\$72,124**.





Priority Groups

Eligibility requirements at CAPS requires families to fall within (at least) 1 of 12 priority groups.

Priority groups are in place to outline specifications on eligibility requirements.

Very Low Income Priority Group Eligibility Threshold Increased from 50% to 150% of Federal Poverty Level

For a family of 4, the very low income threshold increased from

\$13,250 (50% FPL) **\$39,750** (150% FPL)

To meet very low income priority group eligibility requirements, the income threshold (for a family of 4) must not exceed **\$39,750** effective **November 1, 2021**.


CAPS Children by Age Group



Quality Rated Milestone

The final CAPS/Quality Rated (QR) milestone has passed.

Effective December 31, 2021, all families are required to select a star-rated, provisional, or probationary provider.


Quality Rated

- Quality Rated is Georgia's quality rating and improvement system (QRIS) to communicate, assess, and improve the quality of Georgia's early care and education programs
- Programs can be rated 1, 2, or 3 stars. Typically, stars are awarded based on a portfolio submission and live observation.
 - Quality Rated Staff created the Temporary Alternate Rating Option (TARO) for rating programs during the Pandemic.
- Created using stakeholder engagement and national/state research. DECAL commissioned "validation studies" demonstrate the strength of Georgia's QRIS.





Of Georgia's 4,447 eligible providers, 2,796 are Quality Rated.



The quality of 37% of eligible child care providers is still unknown.



How Are Ratings Determined?

Typical Method

- Structural Quality: Programs complete an online portfolio with information about the program.
- Process Quality: A Quality Rated assessor conducts an unannounced observation of the program using the Environment Rating Scales (ERS).
- Total points from Structural Quality + Process Quality + Bonus Points determine the star rating.
- 1, 2, or 3 stars for 3 years

Temporary Alternate Rating Options (TARO)

TARO includes three options, creating a pathway for providers to become rated while in-person observations are not occurring.


- Option A: Portfolio only
 - 1 star for 1 year
- Option B: Portfolio + Quality Rated Virtual Process (QRVP)
 - 1 or 2 stars for 2 years
- Option C: Portfolio + QRVP + Live Observation Virtual Experience (LO-VE)
 - 1, 2, or 3 stars for 2 years

93% of children receiving CAPS are at a **Quality Rated** provider.





Provisional & Probationary Statuses

77 programs have a provisional status

- Programs that are newly licensed and wish to accept CAPS scholarships
- Programs that are new to CAPS

78 programs have a probationary status

- Programs who participate in CAPS, complete the rating process, and do not earn enough points to rate
- Programs who participate in CAPS and allow their rating to expire



2022 Ratings

- Quality Rated will continue to use the cohort system for programs to register for their rating. Cohort 1 = January, February, March; Cohort 2 = April, May, June; etc.
- Quality Rated will rate programs using TARO for Cohorts 1 and 2.
- Quality Rated will rate programs using traditional live observations for Cohorts 3 and 4.
- Process was informed by a provider survey.

Quality Rated Language & Literacy Endorsement

In response to Gov. Brian Kemp's initiative for an increased focus on reading readiness for children entering Kindergarten, DECAL created • the Quality Rated Language and Literacy Endorsement.



- Intensive training period for programs
 - Multi-session classroom language and literacy implementation trainings for teachers
 - Leadership training for program directors
 - Material packages and Technology grants
 - Programs create an implementation and sustainability growth plan
- Eight programs received the inaugural endorsement in October 2021
- Second Cohort
 - Application opened February 4 for 2- and 3-star CCLCs
 - Participation begins April 2022 with endorsements expected to be awarded April 2023.



DECAL's EHS-CCP Grant 101

- Since 2014, DECAL has been an EHS-CCP grantee. Currently in our second 5-year cycle.
- Program is funded for 184 infants and toddlers and their families.
- Services are provided at partner sites (CCLCs and FCCLHs).
- Grant requires layering of subsidy funds not just for our grant but all EHS grantees.
- EHS is 2Gen-focused, and comprehensive services are required.
- Strict requirements related to teacher qualifications and ratios.
- Megan Fickes, new EHS-CCP Director, started October 18, 2021.
