# **Commissioner's Corner** by Commissioner Bobby Cagle



Recently, I had the honor of participating in a national webinar on Pre-K and early childhood education hosted by the Education Writers Association (EWA). Reporters from across the country had questions about Georgia's universal, lotteryfunded Pre-K program.

As DECAL Commissioner, it is always a pleasure to talk about Georgia's Pre-K Program, recognized as one of the top state

programs in the nation based on quality standards, teacher qualifications and enrollment. As we begin our 21st year serving approximately 84,000 four year olds in 3,800 classrooms across the state, I could not be more proud of our accomplishments through this unique public-private partnership. About half of our classes this year will be housed in public schools, the other half in private settings including child care learning centers, Head Start programs, charter schools, military bases, universities and technical colleges.

Since 1995, Georgia's Pre-K Program has been accessible to any four-year-old resident of Georgia regardless of family income. However, almost 60% of our students receive other social services.

Georgia's Pre-K classes in the 2013-2014 school year start between late July and the week following Labor Day. Last year, 66% of all four year olds in Georgia were served by state Pre-K and Head Start, with a statewide Pre-K enrollment of nearly 83,000.

Please join me in thanking Governor Deal and state legislators who have restored the Pre-K school year to 180 days in the 2013-2014 school year. As the availability of lottery revenues becomes clearer, additional strategic decisions will be made concerning future investments in Georgia's Pre-K Program.

I recognize that the Pre-K program has room for improvement, especially in the areas of teacher salaries, class size (now with teacher-student ratios of 1:11), and family engagement and support. I assure you that these concerns will be priorities as we work this year with legislators, providers, parents and child care advocates.

During the Pre-K School year, Commissioner Cagle visits many schools to read to students.

Adams offers families the following tips to help their child's first day in Pre-K go smoother and be less stressful:

- Send your child to school in clothes she or he can manage independently in the bathroom: No overalls.
- Make sure your child's shoes are comfortable for playtime. Slip-on shoes or shoes with Velcro fasteners are easiest for children to manage.
- Visit the classroom before school starts so your child is familiar with the new surroundings.
- Tell your child's teacher about any fears he or she may have.
- Discuss any special dietary needs or allergies your child may have with the teacher and ask the teacher to explain their program's policies around meals.
- Complete any necessary forms or releases your Pre-K provider may require for dispensing medication during the school day.
- Locate the bathroom with your child, and determine any special bathroom routines the school observes.
- Build in extra time for the first day: Make sure you have time to say good-bye.
- Determine if your child needs a blanket for rest time: Can he or she bring a favorite stuffed animal?
- Send along a family photo in your child's backpack in case she or he gets lonely.

**Heatstroke Prevention Day Media Event Reminds Caregivers Not to Leave Children Unattended in Cars** Wednesday, July 31, 2013, was National Heatstroke Prevention Day. The National Highway Traffic Safety Administration (NHTSA) spearheaded a social media awareness day from 10 a.m. to 5 p.m. using the hash tag #heatstroke on both Facebook and Twitter.

More than half of all vehicle-related heatstroke deaths in children are caused by a child accidentally being left in a car, and more than 30% are from a child getting into a hot car on their own. One way to remember the warnings is with the word ACT: Avoid heatstroke; Create reminders; Take action.

In May, DECAL participated with other state agencies and partner organizations in a news conference at the State Capitol reminding families and caregivers of the dangers associated with leaving children unattended in vehicles. DECAL joined these agencies to express our concerns and demonstrate how fast temperatures rise inside a closed vehicle, especially here in Georgia.

Two recent news conferences on the importance of transportation and not leaving children unattended in vehicles are posted on our <u>DECAL</u> website.

DECAL was proud to participate in a "Speak Your Mind Monday" event with State Representative Valenica Stovall (D-74) held July 22, 2013, at Clayton State University. Rep. Stovall's district includes the cities of Morrow, Lake City, Forest Park, Riverdale, and College Park, all located in Clayton County.

DECAL presented its departmental priorities along with updates from Child Care Services, Quality Initiatives, Georgia's Pre-K Program

#### and Nutrition Services.

# **Governor Deal Recognizes Georgia's first Quality Rated Child Care Programs**

On Tuesday, July 16, Governor Nathan Deal held a news conference at the state Capitol recognizing Georgia's first Quality Rated child care programs. Similar to other service industries like restaurants and hotels, Quality Rated uses one, two and three stars to indicate programs that meet a set of standards exceeding the state's minimum licensing requirements. First Lady Sandra Deal and DECAL Commissioner Bobby Cagle also spoke at the event highlighting Deal's vision for improving early education.

"I believe education offers one of the premier ways of attracting businesses, retaining businesses and watching them and the Georgia economy thrive," said Governor Deal. "As much as Quality Rated will benefit Georgia and our economy, it also sets our state's children up for success - and that is equally as important. By giving parents a way to distinguish between low-quality child care and great child care, we can ensure our youngest learners receive a jump start on life."
