From Atlanta driving on I- 75 South

- Take exit 187, turn right onto GA-83/Cabaniss Rd.
- Turn left at the first red light onto Patrol Rd. (Burger King will be on your left and Dairy Queen on your right.)

From Macon driving on I-75 North
