**State Offices South at Tift Campus  
300 Patrol Road

### **From Atlanta driving on I- 75 South**

- Take exit 187, turn right onto GA-83/Cabaniss Rd.
- Turn left at the first red light onto Patrol Rd. (Burger King will be on your left and Dairy Queen on your right.)
- Drive approximately 1/2 mile and the entrance to State Offices South at Tift Campus (SOSTC) is on the right.
- As you enter, advise security you are going to the child care licensing meeting in **Roberts Chapel Auditorium.**

### **From Macon driving on I-75 North**

- Take exit 187, turn left onto GA-83/Cabaniss Rd.
- Turn left at the first red light onto Patrol Rd. (Burger King will be on your left and Dairy Queen on your right.)
- Drive approximately 1/2 mile and the entrance to State Offices South at Tift Campus (SOSTC) is on the right.
- As you enter, advise security you are going to the child care licensing meeting in **Roberts Chapel Auditorium.**

### **From I-20 East of Atlanta**

- Exit #113 onto GA Hwy 83 South
- Follow GA 83 South through Shady Dale and Monticello
- Enter Forsyth city limits and pass under I-75
- Left at 1<sup>st</sup> red light onto Patrol Rd. (Burger King will be on your left and dairy Queen on your right.)
- Drive approximately 1/2 mile and the entrance to State Offices South at Tift Campus (SOSTC) is on the right.
- As you enter, advise security you are going to the child care licensing meeting in **Roberts Chapel Auditorium.**
