From Atlanta, driving on I-75 South

- Take exit 187, turn right onto GA-83/Cabaniss Road
- Turn left at the first red light onto Patrol Road (Burger King will be on your left and Dairy Queen on your right)
- Drive approximately ½ mile and the entrance to State Offices @ Tift Campus (SOSTC) is on the right
- As you enter, advise the security guard that you are there to attend the child care licensing meeting in **Roberts Chapel Auditorium**

From Macon, driving on I-75 North

- Take exit 187, turn left onto GA-83/Cabaniss Road
- Turn left at the first red light onto Patrol Road (Burger King will be on your left and Dairy Queen on your right)
- Drive approximately ½ mile and the entrance to State Offices @ Tift Campus (SOSTC) is on the right
- As you enter, advise the security guard that you are there to attend the child care licensing meeting in **Roberts Chapel Auditorium**

From I-20, East of Atlanta

- Take Exit 113, onto GA Hwy 83 South
- Follow GA 83 South through Shady Dale and Monticello
- Enter Forsyth city limits and pass under I-75
- Turn left at first red light onto Patrol Road (Burger King will be on your left and Dairy Queen on your right)
- Drive approximately ½ mile and the entrance to State Offices @ Tift Campus (SOSTC) is on the right
- As you enter, advise the security guard that you are there to attend the child care licensing meeting in **Roberts Chapel Auditorium**
