Dear Early Education Partner,

As Commissioner of the Georgia Department of Early Care and Learning (DECAL), I am writing to invite you to a Stakeholder Community Meeting relating to the Childcare and Parent Services (CAPS) program. Last fall, DECAL announced some changes relating to eligibility for CAPS. Soon after that announcement, we decided to postpone most of those changes until we had an opportunity to hear from families and stakeholders affected by the changes.

We want to hear from you as a child care provider, an early care and education advocate, a business or philanthropic entity or another stakeholder interested in the well-being of children and families. Your participation will help inform Georgia's plan to maximize access to quality child care; comply with the necessary federal guidelines; and ensure minimal disruption of services to children, families, and providers.

During these meetings, we will share DECAL's vision, provide information on the CAPS program, learn more about your community's needs for supporting young children, and gather feedback on CAPS funding models. Your feedback is essential to our mutual success.

(FYI: DECAL has also scheduled a separate series of meetings for families participating in the CAPS program to solicit their feedback about the program and about ways DECAL can serve them more effectively.)
